Fed.R.App.P. 34(a). 3 In April 1987, Parutsky pled guilty in federal district court to one count of conspiring to distribute cocaine. He was sentenced to imprisonment for twelve years under 21 U.S.C. Sec. 846. He did not appeal his conviction. In November 1987, Parutsky, while incarcerated, wrote two letters to the district court. He challenged in these letters his conviction and sentence on various grounds. The district court determined that the letters constituted a claim for post-conviction relief cognizable under 28 U.S.C. Sec. 2255. The court therefore dismissed the complaint without prejudice, allowing Parutsky to file a properly drafted Sec. 2255 motion. He did not appeal this decision. 4 Instead, Parutsky filed a motion in April 1988 in the district court to vacate, set aside, or correct sentence, attacking his conviction and sentence.
